The meeting was called to order at 7:00 PM by Commissioner Mullins. Commissioner Lipoti opened the meeting with recital of the Land Acknowledgement.

Commissioner Lipoti motioned that the meeting minutes from the November 15, 2022 commissioners meeting be approved. Commissioner Mullins seconded the motion. (*Motion carried, unanimously approved and passed*.)

# Financial Report

The vouchers for the month were reviewed. Commissioner Lipoti motioned that vouchers 12-1 through 12-11 in the amount of \$9,841.13, plus EFT voucher in the amount of \$363.25 for a total of \$10,204.38, plus Construction vouchers (12) C-1, (12) C-2, and (12) C-3 in the amount of \$12,382.50 for a grand total of \$22,586.88 be approved. Commissioner Mach seconded the motion. (*Motion carried, unanimously approved and passed*.)

Financial reports were reviewed. Cash in the Operating Fund at November 30, 2022 was \$178,799.14, the Short-Term Asset Fund was \$42,881.44, the Emergency fund was \$102,335.63 of which \$99,000.00 is invested, and the Construction Fund was \$200.00 balance for a total of \$324,216.21. The balance due on water bills was \$40,393.44, which includes past due accounts of 9,121.26 (one account for \$2,883.63 has had the meter removed with lien filed, one account for \$895.55 has the meter locked).

#### **Engineering Report**

Cost estimate from Wilson is at 3.486 Million. The loan is for \$2.25 million. USDA has offered an additional \$500,000 for the loan amount.

The preliminary reports from Wilson Engineering are about 60% done.

Commissioners need to meet with Engineers and decide on each bid item and what items can be deferred.

#### New Business

Need to inform customers about conservation during power outages.
