The meeting was called to order at 7:00 PM by Commissioner Mullins. Commissioner Lipoti opened the meeting with recital of the Land Acknowledgement.

Commissioner Mullins motioned that the meeting minutes from the April 19, 2022 commissioners meeting be approved. Commissioner Lipoti seconded the motion. (*Motion carried, unanimously approved and passed*.)

## **Audience Participation**

Jordan Boyer discussed emergency planning. He introduced Brooke Burdack from Sierra Country Club, the head of their emergency planning. Mr Burdack explained some of things Sierra were doing in case of an emergency. It was decided this was involved than the water district needed to plan and more for the community to discuss.

### Financial Report

The vouchers for the month were reviewed. Commissioner Mullins motioned that vouchers 5-1 through 5-9 in the amount of \$5,245.84, plus EFT voucher in the amount of \$928.37 for a total of \$6,174.21, plus Construction vouchers for \$16,801.26 for a grand total off \$22,975.47 be approved. The commissioners asked that the testing costs owed to King Water Company for samples requested by the engineer in preparation for the capital improvement projects for \$3,286.00 be paid in June when the loan funds were available. Commissioner Lipoti seconded the motion. (*Motion carried, unanimously approved and passed*.)

Financial reports were reviewed. Cash in the Operating Fund at April 30, 2022 was \$127,192.87, the Short-Term Asset Fund was \$38,288.03, the Emergency fund was \$101,599.19 of which \$99,000.00 is invested, and the Construction Fund was \$0 for a total of \$267,080.09. The balance due on water bills was \$13,813.55, which includes past due accounts of \$6,502.58 (one account for \$1,023.51 is locked off, and one account for \$2,883.63 has had the meter removed with lien filed).
