#### Financial Report

The vouchers for the month were reviewed. Commissioner Lipoti motioned that vouchers 8-1 through 8-8 in the amount of \$26,955.83, plus EFT voucher in the amount of \$686.22 for a total of \$27,642.05, plus Construction voucher (08) C-1 in the amount of \$7,900.50 for a grand total off \$35,542.55 be approved. Commissioner Mullins seconded the motion. (*Motion carried, unanimously approved and passed.*)

Financial reports were reviewed. Cash in the Operating Fund at July 31, 2022 was \$126,616.86, the Short-Term Asset Fund was \$48,288.03, the Emergency fund was \$101,843.60 of which \$99,000.00 is invested, and the Construction Fund was at a zero balance for a total of \$276,748.49. The balance due on water bills was \$9,752.64, which includes past due accounts of \$5,460.36 (one account for \$2,883.63 has had the meter removed with lien filed, one account for \$570.39 has the meter locked).
